

## **The LJS Nursery School**

### **Parent/School Health Agreement**

**I agree to abide by the following health conditions until further notice, in order for, my child to return to school in April 2021.**

1. We will not come to school or bring our child to nursery if my child or anyone in my household bubble (including carers and their families) have any symptoms of illness, however slight, until it becomes clear these are not Coronavirus symptoms. I will phone 0207 432 1294 and ask to speak to Elaine or the headteacher for advice and guidance. If anyone in your family bubble does have Coronavirus symptoms, your family will be required to strictly follow the current quarantine regulations until they are tested.
2. We understand that routine non-invasive temperature testing will take place each morning on arrival at school. My child's teacher will also take my child's temperature if they appear unwell during the school day. I agree to pick my child up from school as soon as possible if they are unwell. During this time, they will be sensitively supported by a teacher in our quarantine room. I understand that my child will then be required to stay at home, whilst medical advice is sought and if Coronavirus is suspected, a test will be available to my child and any other member of my family to rule out Coronavirus. My child will not be able to return to school until their condition has been risk assessed, which may take a few days to become evident, and if a test is indicated and this proves negative, and if positive, any quarantine period has been observed by my whole family and they are all symptom free.
3. We will travel to nursery in the safest way possible, preferably by car or on foot. If we have to use public transport, we will follow the government guidelines by wearing a mask, using hand sanitiser and distancing from fellow passengers. Children under 11 years of age are not required to wear masks on public transport.
4. We will observe all social distancing measures, by keeping 2 meters apart from other parents, teachers and LJS staff, whilst waiting to drop off or pick up our child.
5. We will arrange for one parent or nanny to drop off and pick up our child on a regular basis. However, we understand that there may be times when this may not possible. I will not bring relatives, friends, or pets to school with me. I understand, buggies, bikes, scooters, bags, and car seats cannot be left at school and must travel with me.
6. We will observe the designated drop off and pick up times to keep the class bubbles separate. We will keep to the required 2 meter distance from other parents, teachers and the LJS staff and follow all safety measures and instructions put in place by the nursery school and the synagogue. We will not congregate or chat with other parents outside the building. We will, supervise our child in the queue at all times and will not allow them to climb, run or socialise in the queue or on the forecourt.
7. We will follow all school and Government guidance if anyone in our family or in my child's class bubble is required to follow the track and trace protocols. I will inform the school immediately, if anyone in my family is subject to the track and trace protocols, I will not bring my child to school.

8. We will sanitise our hands upon arrival and departure from the building each time we attend. My child will wear a fresh set of clothes to school each day and all clothes will be washed after attending school. I understand no toys, bring and show, lunchboxes or other items can be brought to school at present.
9. I understand this agreement may be subject to change or may be updated at any time as national or local guidance changes and to keep our community safe.
10. We understand that in the event of any future government lockdown of the country or area, or advice from Public Health England to close the school or a class bubble, we will agree to follow this advice immediately.
11. I agree, if anyone in my family travels outside the U.K. for whatever purpose, during term time or in school holidays, they and my family must abide by government quarantine measures on their return, and not come to school until they have completed the required, quarantine and testing. Some parents, are concerned about any travel through, airports even if it is a green country. Please confidentially let us know about any travel plans, so we can inform families in your class who may be in the high-risk category.
